### SECOND YEAR PROGRAM INFORMATION



The Animal Management & Care uniform protocol for 2024-2025 requires first and second year students to wear their uniform throughout the entire school day. Uniforms are an important part of our program's identity. This reinforces who we are as a community and allows students to feel pride in their school. It also ensures students are not under any pressure because of the type of clothes they wear and all are treated equally. Uniforms prepare students for life after school where many will have to dress according to industry standards for work.
