Daily Professional Dress Policy:

Appearance is important as we have many visitors through MCCC which may be potential future employers. Uniforms are expected to be worn on the first day of school and ALL day.

Uniforms are *not* part of the student fees and the following is the list of the uniform requirements. They can be purchased from anywhere scrubs are sold.

- Three (3) SOLID Black Scrub pants
- Three (3) SOLID Black or SOLID Red Scrub tops. **Required: First Name embroidered on the top right side, in white .48 block font.**
- One (1) pair of comfortable ALL leather tennis shoes or solid nurse shoes.
- Solid black, white, grey, or red short or long-sleeved tee shirts can be worn daily under scrub top. No print on the undershirt.
- A required lab jacket will need to be purchased from USA Custom Apparel (330-722-0818) by September 1, 2026. Lab jacket samples will be available for try on at student orientation along with ordering details. Price for the jacket is estimated at \$58.00 – 62.00
- A minimum \$100.00 deposit is required by the first week of School.

Your acceptance into Cosmetology is contingent upon you presenting your social security card, green card, or working visa to the Medina County Career Center on the MANDATORY COSMETOLOGY STUDENT ORIENTATION NIGHT - Wednesday, August 12, 2026 at 7:00 pm

This requirement is mandated by the Ohio State Board of Cosmetology and will be used to provide proof of authority to earn income. If the above requested information is not received on August 12, 2026, a change in programming will be facilitated as necessary.

In order for our Cosmetology classes to qualify for the State Board Exam, the Medina County Career Center, along with the Ohio State Board of Cosmetology, have put into effect required hours. You must complete **1,500 hours** of training **and** pass all required academic courses to be eligible to apply for the Ohio State Board of Cosmetology to be taken in Columbus, Ohio. It is of the utmost importance that you maintain excellent attendance.
