Daily Professional Dress Policy:

Appearance is important as we have many visitors through MCCC which may be potential future employers. Uniforms are expected to be worn the entire school day, including uniform shoes.

Uniforms are not part of student fees and the following must be purchased before the first day of school. Students are expected to be in uniform on the first day of school. The following is the list of the uniform requirement.

- Three (3) SOLID Black Scrub pants and Three (3) SOLID Black Scrub tops **with First Name** embroidered on the top right side in White. They can be purchased from anywhere scrubs are sold. Embroidery is done at USA Custom Apparel (you will take it there)-229 Harding Street, Medina, OH 44256
- One (1) pair of comfortable ALL leather tennis shoes. Canvas shoes, skaters, and high-tops are not acceptable. Must have socks; no bare feet are permitted.
- Solid black, white, grey, or red short or long-sleeved tee shirts (without any printing) can be worn daily under scrub top. No outer sweaters, coats, flannels, or sweatshirts will be permitted during the school day.

In order for our Cosmetology classes to qualify for the State Board Exam, the Medina County Career Center, along with the Ohio State Board of Cosmetology, have put into effect required hours. You must complete **1,500 hours** of training ***and*** pass all required academic courses to be eligible to apply for the Ohio State Board of Cosmetology to be taken in Columbus, Ohio. It is of the utmost importance that you maintain excellent attendance.
