Daily Professional Dress Policy:

Vision Care I Students are to purchase the following uniform items this summer:

- Clean tennis shoes or Crocs are required. **NO MOCCASINS, COWBOY BOOTS, UGGs, SLIPPERS OR FLIP FLOPS.**
